### **Our History**



In 1980, a group of lesbian and gay activists founded the Gay Community Appeal, raising funds for community projects and organizations. Soon after, the name changed to the Lesbian and Gay Community Appeal, or LGCA.

Every year the Appeal held face-to-face fundraisers like S.O.S. (Supporting Our Selves) and hosted events like Fruit Cocktail theatrical productions and the Fruitcup gala, raising money for organizations that became the backbone of Toronto's LGBTQ+ community - the 519, Buddies in Bad Times Theatre, Black CAP, Toronto PFLAG, Asian Community AIDS Services, the Canadian Lesbian & Gay Archives, Toronto

People With AIDS Foundation, Sherbourne Health Centre and the Metropolitan Community Church of Toronto, amongst many others.

In 1987, the LGCA helped start the Bill 7 Award, a scholarship program LGBT+ students, and in 2007 the LGBT Giving Network, connecting LGBT-serving groups with one another to inspire leadership, action and community philanthropy.

The LGCA encouraged other community groups obtain registered charitable status,

to strengthen their own fundraising capacity. Community One continues this spirit, focusing on marginalized communities as we choose grant recipients, helping them to create an independent, autonomous support network.

In 2008, the LGCA became the Community One Foundation, a name better representative of the diverse community we serve, but we have stayed our committment to funding important initiatives in the LGBTTIQQ2S community.

### Community ONE

### **Grants and Awards**



The Rainbow Grants program began in 2011 with the newly-named Community One Foundation. Every year dozens of individuals and organizations working in the LGBTTIQQ2S commuity apply to fund their initiatives in the areas of health and social services, education, research, advocacy, arts and culture.. The Board of Directors, with recommendations from a volunteer allocations committee working

in these fields, determine which applications have the greatest potential impact on the community.

For almost 40 years as the GCA, LGCA and Community One Foundation, we have given out more than \$3 million in grants and awards for more than 1,100 initiatives in the LGBTTIQQ2S communities of the GTA.

**General Grants** - up to \$1,500 for non-registered charities, usually individuals working in the arts

Foundation Grants - up to \$7,500 for registered charities and trusteed groups



The Steinert & Ferreiro Award - Canada's largest single cash award in recognition of leadership in the LGBTTIQQ2S community - was launched in 2005 through a bequest from the estates of Jonathan R. Steinert and Fernando Gumercindo Ferreiro.

Ferreiro, a successful Toronto psychologist, and his partner Steinert both passed away in the early 1990s, having made plans to leave a community legacy with the LGCA.

Per their wishes, the annual \$10,000 prize is awarded to a community leader who has contributed significantly to the understanding and acceptance of the LGBTQ+ community through the arts and sciences.

Anti-violence/anti-racism educator Bev Bain received the inaugural award, and other recipients have included lifelong activists Dennis Findlay and Doug Kerr, queer parenting educator Rachel Epstein, artists and educators Syrus Marcus Ware and Vivek Shraya and religious inclusion advocates El-Farouk Khaki and Rev. Brent Hawkes.



Started in 1987 by the LGCA and other LGBTQ+ organizations, the Bill 7 Award is an annual scholarship for LGBTQ+ students in financial need who are starting their post-secondary education.

Community One Foundation remains a partner organization, along with fellow founding organization Supporting Our Youth (Sherbourne Health Centre). The partners appoint trustees to manage this important honour.

To date, the Bill 7 Award has funded more than \$120,000 in scholarships to LGBTQ+ students in colleges and universities across Ontario.

# THE JAMES STEWART AWARD

The James Stewart Award was created through the generous bequest from James Stewart, the Toronto-area mathematician, musician and owner of the iconic Integral House, who passed away in 2014.

As one of the LGBTQ+ charities to receive philanthropic support from Mr. Stewart's estate, Community One is honoured to offer this annual award to a charitable initiative offering significant value to the LGBTTIQQ2S communities.

The inaugural James Stewart Award was given to Springtide Resources for their Parenting Teens Exchange, a biweekly group for newcomer parents and caregivers whose teenagers might be LGBTQ+, where they can share experiences and learn to support healthy sexuality and gender development.

### Ways to Give

Our grants are 100% funded by people like you. Your donation helps support organizations which represent the LGBTTIQQ2S community to the broader society, helping work towards greater understanding and inclusiveness. All donations to the Foundation fund are tax receiptable.

Our General Fund (not tax-receipted) supports small projects, often arts related, that unite the community but are not run by a registered charity. This option is popular with donors who see great value in supporting these community building projects.
